



Sedona Talk Radio Hosting Contract

Congratulations on your decision to host your own show with Sedona Talk Radio. It is our goal to help you create the most powerful and successful experience possible for you and your listeners.

We are avoiding long drawn out legal contracts at this time and simplifying our process by enforcing a few guidelines for our hosts to follow.

Let this serve as an agreement between you _____ and Sedona Talk Radio.

You agree to host an Internet Radio program with us _____ times per week/month.

Your first show is scheduled to begin on month: _____ date: _____ year: _____ at time: _____.

Our fee per one hour show is \$50.00 with a one time set-up fee of 197.00. Your payment for monthly fees is due on the first of each month, billed automatically to your credit card through our payment processing system unless other arrangements are made. We reserve the right to charge special payment processing fees if you request other arrangements.

Our contract is month to month with no refunds of shows you have chosen not to do for any reason. If you decide to discontinue your hosting relationship with us we require 30 days advanced notice from your billing date.

Your hosting fee covers the promotion of your show through Sedona Talk Radio and instruction on how to run your show from the comfort of your home or office using only a computer, phone and preferably a good quality phone headset. We will not be in attendance of every show but available for troubleshooting any problems you are having.

This is your show and you are free to invite guests and callers to be on your show as you desire. We will only get involved if we feel any content is objectionable for the good reputation of Sedona Talk Radio. Being that we are a holistic and metaphysically based Internet Radio Station, our topics will often be controversial and cover a broad range of ideas and beliefs. We only ask that you keep your

content clean and respectful of all involved. We don't condone profanity or slander of any kind.

Sedona Talk Radio opened its doors in March of 2007 and is already ranking well with the search engines and drawing a great deal of traffic. Although we cannot promise traffic to your program, we do our best to continually promote the Station Website and our hosts. We are co-collaborators in your success and it is up to you to do your part by promoting your own show through your personal Website, press releases, ads or any other venue you feel would help you achieve the kind of success you desire.

Our fees are offered as a start-up special and subject to change in the future as our traffic increases. You will receive a 90 day notification of any fee increase. Fee increases may or may not apply to already existing hosts with Sedona Talk Radio.

Advertising and Sponsorship:

Our ability to utilize pre-recorded advertising during live shows is dependent upon the equipment we are currently using and the equipment our hosts have available. You are always free to read sponsor ads or talk about your sponsors products or services on your show which is really the easiest way to advertise your sponsors. Plugging in pre-recorded ads would require that either you have a more sophisticated setup on your end or that a Sedona Talk Radio Representative is involved in your show which would be a considerably higher cost to you. Although we will do what we can to help you with your sponsorship we cannot agree to offer your sponsors pre-recorded ad space at this time.

Banner Ads for Sponsors:

You can offer your sponsors a banner ad spot on your Sedona Talk Radio Webpage. Please talk to us about this if you are interested. Any banner ad spots on Sedona Talk Radio's main pages go to the support of Sedona Talk Radio.

Guests:

Having guests on your show is an important part of having a successful talk radio program. It is your responsibility to get us a short bio and photo of any guest you want promoted on your page in a timely manner. Any information provided to us within a week of your program may not be posted.

From time to time we understand an opportunity arises to have an excellent guest available immediately for your show. We will do what we can to accommodate these last minute announcements and postings however there may be an additional fee charged for any rushes.

We can't guarantee that all your guests will receive front page publicity with Sedona Talk Radio, however we do want to be sure to cover *well known* or guests that would have a wide appeal to the Sedona Talk Radio audiences. Please submit your guest information to us as soon as possible.
